Unused Reservations – In the event a reservation is neither cancelled nor changed with advance notice nor used as reserved, no refund shall be issued. However, the ticket will remain valid for travel on a standby basis if it is used within one year from the date the reservation was originally booked. In the event the reservation was paid for with a coupon from a 10-ride ticket book, upon the customer's request a coupon will be returned to the customer's ticket book for future use in lieu of a refund, and there will not be a one-year limitation on the coupon's validity.
